In the National Assembly, Anne-Laure Cattelot is a member of the Finance, General Economy and Budget Committee, and is special spokesperson on the transport budget. She is also Vice-Chair of the special commission tasked with studying the proposed legislation "For a State in the service of a trusting society", and member of the investigative committee on State decisions on industrial policy, particularly in the case of Alstom, Alcatel and STX. Tasked with a mission on "The Industry of the Future" by Prime Minister Edouard Philippe, she is in charge of setting up Development Acceleration Centers for VSBs and SMEs.

Anne-Laure is Co-chair of the brewing industry study group, Member of the France-Portugal and France-China friendship groups, and Member of the study groups on "Lyme disease", "Challenges, evolution and conversion of the manufacturing industry", "National and regional parks", "Navigable waterways".

She was born on October 25, 1988 in Maubeuge (Nord) and was elected Member of Parliament for the 12th district of Nord on June 18, 2017 under the banner of the majority party "La République en Marche." She specializes in China's domestic and foreign policy, Taiwan and the Korean peninsula. Her research interests also include global governance and the practice of diplomacy. Fluent in Mandarin Chinese, she regularly undertakes research fieldwork in China and East Asia and exchanges with a diversity of regional actors.

Alice was formerly Visiting Scholar at Tsinghua University (Beijing), at National Taiwan Normal University (Taipei), and more recently at the Asian Institute for Policy Studies (Seoul). Recognized as one of the best China expert in Europe, she is currently a member of the EU committee of the Council for Security Cooperation in the Asia Pacific (CSCAP) and provides China expertise to the European Union institutions.

She holds a PhD from Sciences Po in International Relations and a Master's from the London School of Economics in International Relations, Economics, and Anthropology (China focus). Among her latest publications: *La Chine dans le Monde* (Ed.), CNRS Editions, February 2018, and *China's Belt & Road and the World: Competing Forms of Globalization* (Ed.), Ifri, April 2019.

In addition to writing on China, Alice is also film-maker: her first full-length film, entitled "Mathilde and Rosette", will be viewable from October 2019.

FU Jing acts as managing director of China Daily's China Watch Institute and columnist mainly addressing China-Europe issues. After eight years as China Daily's chief correspondent in the European Union Bureau, he is now in charge of the communication-led think tank, China Watch.

During his nearly two decades of career, FU Jing's journalism has focused on various fields, and for a long period of time, he has been a member of the news room's breaking news taskforce. Since 2009, FU Jing has been following diplomatic tours for the Chinese president and premier. In 2016 he became the Deputy Chief of China Daily European Bureau.

In 2015, FU Jing won the first prize of China News Award, and he was nominated by the Changjiang and Taofen Journalism Award in 2016. He was also awarded the "May Day Labor Medal" in 2008.

As a writer and translator, FU Jing has had six books published in English or Chinese. As an active volunteer, FU Jing has devoted himself to charitable pursuits and is now responsible for the poverty alleviation educational program.

FU Jing graduated from the Capital Normal University, China School of Journalism and City University London, earning a bachelor's degree in English education, and a bachelor's and a master's degree in international journalism.

Widely recognized as one of the most talented violinists of his generation, GAO Can enjoys an international career during which he has appeared with major orchestras and at prestigious venues and festivals throughout the world.

GAO Can's achievements in violin performance and pedagogy have been recognized by numerous institutions. He was appointed ambassador of the Verbier Festival Orchestra and has become the only official ambassador of Chinese nationality. In 2015, he was elected as the new committee member of the Violin Society of the Chinese Musicians Association. He was also included in the "Impression China" series of the China Post Office. The China Recording Arts Association (CRA) has released a number of albums for him.

In recent years, GAO Can has dedicated a great deal of his time and effort to mentoring the next generation of violinists through teaching, lecturing and giving masterclasses. He was the youngest-ever Associate Professor at Beijing's Central Conservatory of Music. He has held lectures, seminars and workshops at different institutions and universities. GAO Can also co-founded and serves as the Music Director of the Poly WeDo Music Education Program established by the Poly Cultural Group.

Pascal Gentil is based in Beijing, where he is in charge of international relations for Beijing Enterprise JO Construction Group (BEJOC), the consortium responsible for the venue construction for the Olympic and Paralympic Winter Games Beijing 2022.

Pascal has a strong relationship with China, where he trained before every Olympic rendezvous. After the Beijing 2008 Olympic Summer Games, he worked six years in Beijing for the French group Veolia Environment Services.

The first French Olympic Medalist in Taekwondo, Pascal has been an Olympic medalist twice, a three-time World Cup winner, a three-time European champion, and 18 times the French champion. He has been the captain of the French Taekwondo National Team for 20 years. An emblematic figure in his sport, he is now a member of the board of the French Taekwondo Association and World Taekwondo and has been elected President of World Taekwondo Athletes' Commission.

A good communicator, intrepid and target-oriented, he played a key role in promoting taekwondo as an Olympic sport, supported each Olympic Bids from France, and in particular Paris 2024. A strong actor in sports diplomacy, he has also been an active promoter of peace with the French Ministry of Sports or foundations like Peace & Sport.

Since July 2019, he is also the CEO of Saint Barth Security Services, advisor in risk management and in securing Chinese interests in Europe and Africa.

Pascal is a graduate of Paris ESSEC Business School.

YUAN Yuyu is the founder and CEO of Medprin Regenerative Medical Technologies Co., Ltd., and Deputy to the National People's Congress.

He obtained his Ph.D. degree in Bioengineering from Clemson University, South Carolina, USA in 2007. He makes significant progress on the study of regenerative medicine and biomedical engineering, has published more than 20 papers and applied more than 200 patents worldwide.

In September 2008, aimed to realize the industrialization of world leading regenerative medicine technologies, and break the long-term monopoly of imported high-end implantable medical device in the Chinese market, He went back to China and founded Medprin with his team. They established the 3D bioprinting technology platform and developed various new implantable medical devices for accurate and efficient tissue repair. To date, Medprin's products have entered more than 60 counties and regions, competing with world leaders and benefiting about two hundred thousand patients worldwide.

He is one of the experts and committee members of the Additive Manufacturing Alliance of China and committee members of several professional societies, promoting 3D printing development in the biomedical industry in China.

ZHENG Tengfei got her bachelor's degree in science from Beijing University in 2003 and a PhD degree in Biochemistry from MIT in 2014.

After graduation from MIT, Tengfei chose to leave academia and return to China. She worked in Henan Provincial Department of Environment Protection for a year, focusing on air pollution management.

Then she switched her career path to education. She designed curriculum for an afterschool science education institute, and coached high school and undergraduate students preparing for upper-level degree studies. In 2016, Tengfei joined Shanghai Pinghe School, a private school with grade 1-12 students. She has been working on reconstructing a 12-year continuous science curriculum, aiming to offer good science literacy training to all students. She is also in charge of the opening and operation of a new primary school campus, Shanghai Little Bridge School, formatting the school curriculum scheme, including student, teacher and parent curricula. Besides school management and curriculum design, she is teaching IBDP chemistry and theory of knowledge for high school students and science for first graders.

Shanghai Pinghe School (SPS), located in Pudong, Shanghai, was founded in 1996. In 2015, SPS was named by Forbes magazine as one of the eight most popular international schools in Shanghai. SPS high school was certified by the International Baccalaureate Organization in 2002, and most courses are taught in English. More than 90% of SPS graduates are admitted by top-50 US universities. As one of the two new primary school campuses, Shanghai Little Bridge School has already become a very popular choice among middle-class parents after one year in operation.
